West Union City Council met August 1, 2016 at 6:00 P.M. in Council Chambers with Mayor Kent Halverson presiding. The meeting began with citing the Pledge of Allegiance.

- Approval of the Motion was made by Granger, seconded by Stansbery, to approve the agenda

Street Closings turning east on E. Elm, and ending by Burnham-Wood Funeral Home.  
Activities will take place on S. Vine from the Elm Street intersection to Gus'

2017-04 approving Annual Street Financial Report with Beginning Balance of \$197,505,  
Annual Street Revenues of \$587,388, and Expenses of \$725,852, for Ending Balance of  
Financial Report \$59,041. All Aye. Carried.
